
## I. Getting Started

- 1. Go to <u>citiprogram.org</u> and click *Register*.
- 2. Search for Harvard Pilgrim Health Care under Your Organization Affiliation.
- 3. Complete the required registration questions.
- 4. Register for the courses in your assigned learner group.

These instructions guide you step by step through the questions that you will see on the CITI website. **Our instructions are bolded. Answer the questions as outlined below.** 





## III. When does the training need to be completed?

CITI needs to be completed within 5 days of hire and before any involvement in human subject research. Research studies will not be approved until all key personnel and research project staff completes the training.

### IV. What if I have previously taken the basic CITI training at another institution?

If you have taken the course **within the past 3 years**, log on using your username and password. From the learner's menu, click *affiliate with another institution* and type in and select *Harvard Pilgrim Health Care* from the drop down menu. If additional coursework is required, you will be prompted to take the refresher course (see refresher instructions). You will also be required to submit a copy of your basic course completion.

## V. How long will it take to complete the training?

Depending on the course it can take anywhere from 20 minutes to 6 hours to complete an entire course in multiple sessions. This can be completed remotely, from your home or from a laptop. Exit and Re-enter the course at any time with your username and password. Any completed work will automatically be saved.

### VI. What happens if I do not receive a passing score?

The minimum passing score is set at 80%. If you do no pass, you may repeat any quiz in which you did not receive 100%.

## VII. When I have completed the required training, what do I do?

When you complete the program, you should save a copy of your Course Completion Record for your own records.
